### Marion Lake Club Membership Application

#### TYPES OF MEMBERSHIPS:

##### **FAMILY MEMBERSHIP: \$1500**

Our Family Membership is for anyone 31 years old or over, who would like use of the golf course, and full club privileges including golf, pool, marina and slip, tennis. Spouses and school age children living in the home, or in college (under 25) are included in the family membership. Grandchildren and children ages 12 and under who stand in the relationship of children are included for free in this membership.

##### **JR FAMILY (UNDER 30) MEMBERSHIP: \$750**

Our Family Membership is for anyone 30 years old or under, who would like use of the golf course, and full club privileges including golf, pool, marina and slip, tennis. Spouses and school age children living in the home are included for free in this membership.

##### **GOLF ONLY MEMBERSHIP: \$900**

Includes only golf. No other amenities are included. If you would like to have a boat slip, trail fee, or private cart storage you must move up to one of our Family Membership Choices.

##### **STUDENT MEMBERSHIP (UNDER 25 AND FULL TIME STUDENT): \$480**

Our Student Membership is for anyone under the age of 25 and under who are a full time student. You must provide valid proof of the school you are attending. This membership includes use of the golf course, and full club privileges including golf, pool, marina, tennis. Spouses and children are not included in this membership, and you can not have access to the boat slips under this membership.

##### **SOCIAL MEMBERSHIP: \$1100**

Includes full club privileges including golf, pool, marina and slip, tennis. Spouses and school age children living in the home, or in college (under 25) are included in the family membership. Grandchildren and children ages 12 and under are included for free in this membership. Golf is not included in this membership package, you would pay a public rate to play.

#### Available Amenities of the Marion Lake Club (depending on membership type):

*All amenities can be billed Annually, Quarterly, or Monthly and divided out equally. This is an updated change from our prior payment terms.*

- Boat Slip -*Must be a Shareholder*: \$1,140
- Private Cart Trail Fee - Single: \$630; Family: \$655
- Cart Storage - Electric: \$300, Gas: \$220
- Range Plan - Single: \$200, Family: \$235
- Handicap - *Must pay annually* \$30

#### DUES PAYMENT CYCLE:

**ANNUAL:** All dues and chosen amenities payable within 45 days of the first billing quarter. Check, Cash or Credit Card accepted.

**QUARTERLY:** All dues and chosen amenities payable within 45 days of the first billing quarter. **ACH or Credit Card must be on file and billed automatically.**

**MONTHLY:** Total membership amount, divided into 12 equal payments over the course of the year. Payable within 10 days of the first day of the billing month. **ACH or Credit Card must be on file and billed automatically.**

**\*\*Shareholders will receive a \$50 credit off of their first bill of the year.\*\***

This membership application serves as a binding document between the Member and Marion Lake Club, Inc. ensuring that the entire membership of one year will be fulfilled and paid for. If a member refuses to pay, or the Board of Directors revokes membership to be reinstated the current Rules and Regulations will go into effect.
